

# Ann Arbor Beaver Conflict Offers Lessons, Opportunities

A colony of beavers that took residence at the city-owned Leslie Park Golf Course in Ann Arbor, Michigan, were lethally removed by city and county officials decided to euthanize them, to the dismay of city residents. The decision caused quite a controversy, as animal rights groups advocated for a more humane option to be explored in the wake of the decision, especially in light of the discovery that officials had used <u>outlawed conibear traps</u>. The city had been in contact with a BeaverCorps professional about installing a coexistence device, but had felt unable to wait for a formal proposal. Beaver advocates and animal rights groups are currently working with City of Ann Arbor and Washtenaw County officials to educate about the ecological value of beavers and to develop a beaver management plan going forward, but challenges remain due to the state's permitting process and regulations against beaver relocation.

## Oregon Bans Beaver Trapping on Impaired Streams on Public Lands

In June, the Oregon legislature passed a bill, HB 3932, that bans beaver trapping on federal or state lands (excluding tribal land) along streams that have been designated as "impaired" by the Oregon Department of Environmental Quality. The bill requires the Oregon Department of Fish and Wildlife to publish a map showing the waterways where the new beaver protections apply.

While acknowledging that the bill is an important first step, Suzanne Fouty, a retired hydrologist and soil specialist who worked for the U.S. Forest Service, said House Bill 3932 has significant flaws. Fouty's concern stems not from land the

legislation covers, but from what it does not. She said only about 46% of the state's streams have been surveyed for the pollutants that can lead to their being designated as impaired. That leaves many thousands of miles of streams, and tens of thousands of acres, left out of the bill's protections and thus deprived of the potential benefits of beavers, Fouty said.

The public trust doctrine (PTD) is a common law principle that has been primarily significant in two areas: land access and use, and natural resource law. The doctrine requires states to manage certain natural resources for the benefit of the public. While the PTD has traditionally been used to manage water resources, lawsuits have recently sought to expand the doctrine to include natural resources impacted by climate change. Protecting impaired watersheds on public lands from beaver trapping will improve ecosystem function, from which the entire public will benefit. A 2024 report by the Oregon Department of Fish and Wildlife showed that only 4 percent of beaver harvest takes place on public lands. Most recreational trapping in Oregon occurs on private lands, which will not be affected by HB 3932.

#### **Beaver Festivals Galore**

Putting on a beaver festival is a great way to advocate for your local beavers. It's a lot easier to convince landowners and land managers to try coexistence strategies when your local community is educated about the many ecosystem services that beavers provide. Recent festivals include:

- The OG <u>Martinez Beaver Festival</u> in California, held on June 28 and organized by Worth a Dam's Heidi Perryman, who was inspired to throw the first festival 11 years ago because, "I realized the beaver would be safer if we threw a party for them every year," Perryman said.
- The <u>Durango Beaver Festival</u>, held on June 14 in Durango, Colorado, presented by Give a Dam.
- The <u>Northfield Beaver Fest</u> in Northfield, Minnesota, held on May 17 and organized by students at Carleton College in partnership with Carleton's Environmental Studies Department, Environmental Carls Organized, and Carleton Sustainability.
- The <u>San Luis Obispo County Beaver Fest</u>, held on April 12 and organized by the SLO Beaver Brigade.



#### **Beavers Welcomed Back to Portugal**

The last known record of beavers in Portugal probably dates back to the end of the 15th century. However, after two decades of population recovery in Spain, and recently with signs of documented proximity to the Portuguese border confirmed in several monitoring actions carried out in the field by Rewilding Portugal, beaver signs have reappeared in the form of gnaw marks and dams. According to Pedra Prata of Rewilding Portugal, "The beaver is a natural ally in restoring the health of our rivers and wetlands and has a fundamental role to play in our river ecosystems."
